SCM/59/AKM/13(a)/22 dt. 25/08/2022).
 It is understood that this agreement will come into effect after being signed by the two
- parties and will be established for a period of five years.
- The renewal of the agreement is chargeable at the end of the tenure/period and the documentation formalities shall be done by the both parties within 30-45 days prior to the date of termination of this agreement.
- The First Party has agreed to provide the logistic support including pick up, transport, carry and recycle / dispose of the solid waste (generated by the 2nd Party) from the second party once in a week.
- The both parties have agreed to conduct the various programmes (Such as seminars, workshops, observance of important days, awareness programmers, rallies etc.) jointly on solid waste management, environmental protection and other related issues in a regular
- 6. Either party can terminate this agreement by giving 45 days written notice in advance to the other party. However, the other party is not entitled to claim any compensation for such premature termination, if it is done on account of reasonable and sufficient grounds.

 7. If any dispute arises in respect of the MOU, in that case, both the parties will discuss and settle the matter amicably.

 8. This agreement is a non-exclusive agreement and two parties remain free to enter into similar agreements with other parties.
